Public Hearing - Proposed 2013 Budget

Public hearing opened at 7:31 p.m.

Clerk-Treasurer Steve Braatz and Finance Director Diana Doherty gave a presentation on the 2013 budget. Highlights include:

- Loss of an additional \$60,585 from State Transportation Aid and Shared Revenue.
- Loss of \$14,100 for Fire House Rent due to new Fire Department Agreement with Town.
- Shifted \$44,600 in smaller dollar, recurring equipment purchases from capital equipment fund to operating budgets to properly classify non-capital purchases that in the past have been included with capital purchases.
- Increase of \$129,470 in tax levy for Fire Department due to over estimation of ambulance revenues in prior years (\$98,670 reduction in Village share) and increase in expenditures (\$30,802) due to contractual salary and compensation increases and moving non-capital purchases to operations.
- Village-wide revaluation completed in 2012, causing the assessing costs to drop back to normal, a reduction of \$36,600 in expenditures from the 2012 budget.
- Employee contribution to pension increased from 5.8% to 6.85% of salary (excluding Police and Fire).
- Health insurance premiums increased 3.3% from the State insurance.
- Addition of \$34,350 in expenditures for joint venture/contract with Town of Mukwonago Recreation Department.
- Addition of \$45,000 in expenditure toward Economic Development to assist STH 83 SAC downtown redevelopment planning process.

- Addition of \$115,000 in revenue due to shifting \$50 of the \$167 garbage/recycling cost to residents who use garbage/recycling service as an annual fee. Combined with other aspects of the budget, this will result in a reduction of \$102,772 in the property tax levy for the Refuse Collection Fund.
- The property tax levy for Operations and Capital Purposes increased \$43,129 or .91% of the total levy.
- Total Tax Base for 2012 Taxes payable in 2013 is \$689,525,100, a decrease of \$67,151,100, or 8.89% over 2011.
- For Waukesha County properties, an owner of property whose assessment dropped more than 9.6% of the 2011 assessment would see a reduction in taxes.

Proposed two amendments:

FIRE DEPARTMENT FUND

- Reduction of \$6,782 out of salaries.
- Offsetting revenue Reduction of \$6,782 out of ambulance county collections.

CAPITAL EQUIPMENT FUND

- Reduction of \$12,950 for street sweeper expense.
- Offsetting revenue Reduction of \$ 12,950 from Transfer from Designated Funds.
