#### Village Tax Rate Updates

The Village Tax Rate only represents roughly 35% of the total property tax bill.

The total Village Property Tax Levy for all the Village purposes is \$6,671,835.75. (including Tax Increment Financing Increments)

The total equalized value for 2019 is \$926,137,500 which is an increase of 3.34%.

#### **Lottery and Gaming Credit**

You may claim a lottery and gaming credit on one tax parcel in the State of Wisconsin if you were the owner of the described property on January 1, 2019 and used it as your primary residence for the year.

If you qualify, you should already see a Lottery and Gaming credit for this parcel on your tax bill. If you qualify, but did not receive the credit on your tax bill, we can make that adjustment for you.

## **First Dollar Credit**

You do not need to apply for the First Dollar Credit. The credit is calculated on the total equalized value of the parcel for both land and improvement values. **The credit** is funded from **the state** general fund.

The first dollar credit is paid on any real estate parcel with at least one improvement. The credit equals the school property tax on a certain amount (the credit value) of the market value of a qualifying real estate parcel

# **Dog & Cat Licensing**
